**12653 VE Day**

The unknown Tommy's have arrived and Cllr Johnson and Greenbeck had fetched one for all to see. Discussion was held regarding the siting of the 6 Tommy's, and all agreed that they should be sited at the entrances to the village on Caistor Road and Grimsby Road, alongside the Laceby signs. One to be sited near the bench at the Mulberries, one in the Cemetery, one in the Church yard and one at the Stanford Centre.

Cllr Barford, Cllr Greenbeck and Cllr Johnson will meet on Saturday morning to site the statues.

It was agreed that the poppies will be ordered to be placed on lamp posts, starting in the Square / centre of the village with a concentration of poppies, and gradually petering off, to also include the route up to the Cemetery.
