Minutes of the Laceby Parish Council Meeting held at the Stanford Centre Cooper Lane Laceby on Tuesday 15 January 2013 at 7.30 p.m.

10795 Planning Matters

It was noted that a non material amendment following grant of DC/62/11/WOL (Alterations, erect 2 two storey extensions and first floor balcony to existing golf club house and alterations to existing vehicular access) to alter the rear two storey toilet and office and erect storage block extension to clubhouse.

No Plans were received in respect of the above amendment but the Parish Council took note of it.

It was noted that Councillor Greenbeck had been invited to speak on behalf of the Parish Council – he gave a brief update in respect of this informing those present that he would speak on behalf of the Parish Council regarding traffic regulation orders for the village.

10796 Information Exchange

The Chairman mentioned that the village was to get a new Police Officer and it was agreed that it would be great for the village if this was the case.

Councillor Marshall stated that the younger people no longer grouped together in the Square area like they used to do; because they were always on their computers on facebook!

Concerns were raised in respect of one of the bridle roads being gated off – Councillor Marshall stated it could be gated as long as it did not prevent horses passing through. Gates to stop vehicular access were allowed.

10797 Budget for 2013/2014

The Clerk had provided figures for a suggested expenditure to the year ending 31 March 2013 and a possible budget for the forthcoming financial year.

The budget itself was discussed at length and with no major changes it was proposed by Councillor Turner and seconded by Councillor Schofield that the budget should be accepted; and this was resolved unanimously.

10798 Precept for 2013/2014

The Laceby Parish Council having given careful consideration to the budget noted that the North East Lincolnshire Council were to offer the Parish Council a grant of £3,646.00 towards running costs.

The Clerk was asked by the Chairman if this money was to be included within the precept and was informed that this would be the case.

It was therefore proposed by Councillor Marshall that the precept should be set at the same as last year to include the grant money making a precept of £32,000.00. This motion was seconded by Councillor Mumby and resolved unanimously.

Precept to be made up as follows:

Laceby Parish Council actual Precept 28,354.00 PLUS Grant receivable from NELC 3,646.00

Total Precept for 2013/2014 £ 32,000.00 – no increase on last year
